- A. ACME CANINE, LLC (AC) will instruct the owner on proper training techniques in order that the puppy is trained to perform in accordance with the program agreed upon between AC and the owner. Owner understands and agrees that, should owner fail to cooperate fully in completing the owner training sessions, AC cannot and does not assume or accept responsibility for the behavior or performance of the puppy after AC is no longer involved in conducting training sessions.
- B. If the puppy shows evidence of a medical problem during training sessions conducted by AC personnel, AC shall have the right to terminate the training session. Training sessions will resume when AC observes the puppy is well and able to continue training without impeding the health and safety of the puppy. If the training session is terminated after AC arrives at the residence, a nominal \$35 fee will be charged.
- C. AC agrees that, while the puppy is being trained by AC, AC personnel will exercise the utmost diligence and care to protect the health and safety of the puppy. However, owner agrees that AC has no liability for loss of or damage to the puppy or owner's other property resulting from training exercises conducted while on the owner's premises. After AC leaves the owner's premises, AC cannot and does not accept any responsibility for the illness, injury or death of the puppy or of any person or animal or damage to any property caused by the puppy.
- D. Training sessions will be scheduled at a time and date agreed upon by AC and owner. A minimum number of training sessions shall not be required. Payment will be made at the time each training session is conducted or at the first lesson if a package is purchased.

- E. Owner agrees to provide no less than 24 hours notification of cancellation of a lesson. If notification is provided less than 24 hours from the scheduled lesson time, owner agrees to pay a nominal \$35 cancellation fee.
- F. Owner represents that owner is the legal owner of the puppy, that the puppy is free and clear of any mortgage or other encumbrance, and that owner has read this agreement in its entirety.
- G. Owner grants AC, its representatives, and its staff the right to take photographs of me and/or my pet/s, and to copyright, use, and publish the same in print and/or electronically.
- H. Owner agrees that AC may use such photographs of me and/or my pet/s with or without my name and for any lawful purpose, including, for example, such purposes as publicity, illustration, advertising, and Web content.
